Pursuant to the provisions of Article 92, paragraph 1, item 10 of the Maritime Domain and Seaports Act (Official Gazette No. 24/23), Article 18, paragraph 1, item 14 of the Statute of the Port of Rijeka Authority, and Articles 15, 22 paragraph 3 and 53 paragraph 2 of the regulations on the handling of dangerous goods, the conditions and method of performing transport in maritime traffic, loading and unloading of dangerous goods, bulk and other cargo in ports, and the method of preventing the spread of spilled oils in ports (Official Gazette Nos. 51/05, 127/10, 34/13, 88/13, 79/15, 53/16, 41/17, 23/20 and 128/20), the Governing Council of the Port of Rijeka Authority, at its ____ session, held on _____, with the prior consent of the relevant Ministry.

**Regulations
on
amendments
to the port regulations**

determining the classes and quantities of dangerous goods that may be handled within the port or with which a vessel may enter the port; the areas within the port where the handling of such dangerous goods is permitted; the areas designated for vehicles awaiting loading and unloading; as well as the areas designated for the storage of removed dangerous goods.

Article 1.

In the Regulations determining the classes and quantities of dangerous goods that may be handled in the port, or with which a vessel may enter the port, the areas of the port where such goods may be handled, the areas designated for vehicles awaiting loading and unloading, and the areas for the storage of removed dangerous goods (hereinafter: the Regulation), Article 3 shall be amended to read as follows:

„The following classes and quantities of dangerous goods are hereby determined as those that may be handled within the port area managed by Port of Rijeka Authority, or with which a vessel may enter the port area.”

a. IMDG

CLASS	NAME	QUANTITIES (NET)
Class 1	Explosives	5.000 tons
Class 2	Gases under pressure, liquefied or dissolved under pressure.	25.000 tons
Class 3	Flammable liquids	800.000 tons
Class 4.1, 4.2, 4.3	Flammable solids, substances liable to spontaneous combustion, substances which, in contact with water, emit flammable gases (overall class 4)	100.000 tons
Class 5.1, 5.2	Oxidizing agents, organic peroxides (overall class 5)	30.000 tons
Class 6.1, 6.2	Toxic substances, infectious substances (overall class 6)	30.000 tons
Class 7	Radioactive substances	Subject to prior assessment
Class 8	Corrosive substances	80.000 tons
Class 9	Miscellaneous dangerous goods	400.000 tons

For the precise classification of dangerous goods transported by sea, the International Maritime Dangerous Goods Code (IMDG Code) is used, as well as the European Agreement concerning the International Carriage of Dangerous Goods by Road (ADS) with its integral parts, Annexes A and B.

Article 2

In the Regulations, Article 6 is amended to read:

"Places for handling dangerous goods, locations for waiting for vehicles (trucks and wagons) for reloading and locations for removing vehicles with dangerous goods in case of emergency in the area of the Rijeka port basin,

Location Brajdica South are:

- Kostrena West and South Pier, Riva Galioti and Gat Brajdica – for transhipment and transit of all IMDG Classes. Transhipment of dangerous goods according to IMDG 1 and 7 is allowed provided that they arrive packed in containers.
- Area in front of warehouse number 46 for transhipment of all classes except IMDG Classes 1 and 7;
- At a specially designated area of the Container Terminal, all Classes of dangerous goods packed in containers, except IMDG Classes 1 and 7, can be stored.
- On map no. 2, handling points, vehicle waiting points and vehicle removal points are listed;

Location Zagreb Pier – Rijeka Gateway Container Terminal:

- Rijeka Gateway Container Terminal - for transhipment and transit of all IMDG Classes. Transhipment of dangerous goods according to IMDG 1 and 7 is allowed provided that they arrive packed in containers.
- At a specially designated place of the Container Terminal, all dangerous goods packed in containers, except IMDG Classes 1 and 7, can be stored.
- On map no. 2a, handling points, vehicle waiting points and vehicle storage points are indicated."

Article 3

Article 11 of the Regulations is amended to read as follows:

"Concession holders in the port area managed by the Port of Rijeka Authority are obliged to align their act within 6 months from the date of entry into force of the amendments to these Regulations. Concession holders shall submit a copy of the aligned Act in accordance with the previous paragraph to the Port of Rijeka Authority."

Article 4

The Regulations are amended by adding the annex "Map No. 2" to the annex "Map No. 2a", which contains the markings of dangerous goods handling locations, waiting areas for vehicles (trucks and wagons) for reloading and places for sheltering vehicles with dangerous goods in case of emergency in the area of the Rijeka port basin at the Zagreb Pier - Rijeka Gateway Container Terminal location, all as shown in Annex 1.

Article 5

These regulations on amendments to the port regulations shall enter into force on the eighth day from the date of its publication on the notice board of the Port of Rijeka Authority, with the previously obtained consents referred to in Article 15 of the Regulations on the handling of dangerous goods, conditions and manner of carrying out transport in maritime transport, loading and unloading of dangerous goods, bulk and other cargo in ports, and the manner of preventing the spread of leaked oils in ports (Official Gazette, No. 51/05, 127/10, 34/13, 88/13, 79/15, 53/16, 41/17, 23/20 and 128/20).
